## WOULD YOU LIKE TO BE A TRUSTEE OF MFM IN THE UK?

Mountain of Fire and Miracles Ministries (MFM) in the United Kingdom seeks additional Trustees for its current Board of Trustees. You are invited to apply by using the contact details set out at the end of this Notice and by the given deadline. MFM in the UK currently has three serving Trustees and due to the continuing growth of the church, the Ministry will benefit from having more. There are no particular qualifications required. However, it would be helpful, if in your application, you set out any special skills that you possess, giving detailed examples. There are no particular barriers to applying.

### **However, you should note the following:**

- 1) Due to the volume and nature of the work involved, the position would be better suited to a person who works part-time or is retired or about to retire.
- 2) There can sometimes be a large amount of paperwork to be mastered and actions to be taken within a very tight space of time
- 3) Many Trustee meetings may be held by telephone conference calls, and much work is done online, However, face to face meetings need to be held frequently and sometimes within a short period, at certain times of the year. This is in addition to the usual Trustees' twice a year meetings. Trustees may also need to attend meetings with other bodies from time to time, such as the Regional Overseers' Group, or other Groups within the Ministry. Trustees may also be called upon to serve on project sub-committees set up for specific periods and specific purposes from time to time. Trustees may be required to prepare, file, or contribute to Reports, Statements, Questionnaires etc. arising out of the work required to fulfil the duties and responsibilities of Trustees. In short, the role of Trustee can be very time-consuming.
- 4) You will be dealing with highly sensitive information, much of it to do with people's personal lives. Thus, it is essential that you are able to keep the highest levels of confidentiality.
- 5) You will from time to time be dealing with vulnerable individuals and families. For this reason, you will require a great deal of tact, sensitivity and empathy. It is desirable (but not compulsory as you can be trained) for you to have experience or knowledge of safeguarding measures or procedures.
- 6) **Branch/Zonal/Regional Pastors of MFM, and current members of MFM UK Management Committee and Nehemiah Group need not apply.**
- 7) Your geographical location in MFM UK does not matter. However, you must be able and willing to attend meetings in London at short notice.
- 8) Your nationality or origin does not matter. However, all applicants must have a **demonstrable** right to live and work in the UK free of all limitations and conditions.
- 9) You should **PREFERABLY**, be a longstanding member of MFM in the UK and have an understanding of, and commitment to, the mission of MFM as a Charity in the UK
- 10) If you are unfamiliar with the duties, responsibilities and expectations of Trustees of a Charity in the UK, it is **strongly recommended** that you research these before you apply. For example, by visiting the relevant portions on the Charity Commission's website at [www.GOV.UK](http://www.GOV.UK).
- 11) You should also familiarise yourself with the contents of the MFM UK Staff Handbook (copies of this may be obtained from Pastor Ayo Oluwalagba, MFM UK Administrator)
- 12) You must not have a criminal record (whether or not it is a spent conviction)

- 13) You must be at least 18 years old.
- 14) You must not be a person previously or currently disqualified under the Charities Acts.
- 15) You must never have been declared bankrupt nor ever declared bankruptcy yourself.
- 16) You must never have been convicted for any type of fraud or money laundering.
- 17) This role is a voluntary, unpaid role, although your reasonable agreed expenses e.g. for travel, or necessary childcare, may be covered by the Charity.
- 18) You must be willing to work co-operatively with the MFM UK Management Committee, whilst recognising that the role of Trustee and that of Management Committee members are distinct but inter-dependent.
- 19) You must be prepared to undergo an enhanced DBS check
- 20) You must be committed to the spiritual vision of MFM UK


Application is by C.V and covering letter (with your passport photograph attached) stating on no more than one page of A4, why you consider yourself suitable to serve as a Trustee of MFM UK. Your C.V or covering letter should contain the name and contact details of three referees, one of who should be your current or former Branch Pastor or Regional Overseer. A second referee must be a current or previous professional/employment-related or academic referee. All three referees must have known you for at least 3 years.

**If you are shortlisted for interview, you will be notified in writing and given a date and time to appear before a selection panel. If you are approved by the selection panel, you will thereafter undergo a further interview with the General Overseer (who is also Chairman of the MFM UK Board of Trustees) and you may be required to undergo tailor-made sessions of special prayers. After the selection and interview process is complete, **successful candidates ONLY** will receive a letter of appointment from the General Overseer. If you do not receive a letter of appointment within 14 days of your interview with the General Overseer, you should assume that you have been unsuccessful on this occasion.**
